This amount was meant for the purchase of new machines and chemicals for the farms and establishment of a new farm in Swaziland.



I have two options for you, firstly you can choose to have certain percentage of the money for nominating your account for this transaction, or you can go into partnership with me for the proper profitable investment of the money in your country.

Whichever the option you want, feel free to notify me. I have also mapped out 5% of this money for all kinds of expenses we might incur in the process of this transaction. If you do not prefer a partnership I am willing to give you 30% of the money, while the remaining 65% will remain for my family use. Finally please treat this matter as urgent. I'm in dire need to leave this country soonest as I am just an asylum.
